THIS COURT ORDERS that:

1. The retainer agreement entered into with the representative plaintiff John Morel is approved under section 38 of the Class Proceedings Act;

- 2. A fee of \$6,219,736.99 inclusive of taxes is approved and awarded to Rice Harbut Elliott LLP, Thomson Rogers LLP and Sotos LLP as Class Counsel payable as a first charge on the settlement funds, with 90% (\$5,597,763.29 inclusive of taxes) being paid out as an interim fee, on October 29, 2025;
- Disbursements of \$486,239.80 are approved and are payable to Class Counsel as 3. a first charge on the settlement funds;
- An honorarium of \$5,000 is approved and awarded to representative plaintiff John 4. Morel payable as a first charge on the settlement funds; and
- The legal fees, disbursements, honorarium and applicable taxes shall be paid from 5. the settlement funds, pursuant to the terms of the Settlement Agreement.
